A:	Yes, any parts of Attachment B that are not applicable to the Proposer's proposal can be marked as not applicable.

Q:	Can the vendor submit pricing for each year factoring in the economic adjustments / increases for the base and optional years?
A:	Yes, there are no restrictions or limitations to how a Proposer desires to structure their pricing schedule proposal.

RFP 2490 Drug Screening Services and Related Supplies

Q:	Our company security policies may not let us upload sensitive documents to a storage space like Box. May we email our response to the rfp@orcities.org email address if we find there are issues with uploading our documents? Or mail the proposal to the Salem address with a thumb drive copy?
A:	Currently, there is no option to submit a proposal outside of what is outlined in the solicitation. Fortunately, we have had zero issues with a proposer uploading to Box. Technically, LOC can choose to amend the solicitation. I cannot assure you this would warrant an amendment, but you may want to factor that into your timeline if you believe it is a concern.

Q:	What is the anticipated start date for this contract?
A:	The contracting part is expected to begin on February 17, 2025. How long it takes to execute the agreements is primarily based on how long it takes for the vendor to review and finalize any possible redlines.

Q:	Please verify that the LOC will allow for vendor insurance to include the LOC as an additional insured per written contract and name as a certificate holder, without specifically naming the LOC on policies.
A:	Correct, it is not required to name the LOC on the policy specifically.

Q:	Can the LOC specify how many participating agencies, nationwide, are currently actively part of this cooperative? How many participating agencies are purchasing from one of the LOC's cooperative contracts currently, 1) within Oregon and 2) outside of Oregon?
A:	Approximately 200 OR cities are members of the LOC. NPPGov has 50,000+ government members. Member purchasing information for both member organizations is not available to share.

Q:	Does the LOC have an estimate of how many of the participating agencies will utilize this cooperative for the purposes of substance abuse testing (non-employment versus employment drug testing)? Have a number of existing agencies expressed interest?
A:	The solicitation is an Interstate Cooperative Procurement Solicitation and does not pertain to any specific project(s). The purpose is to provide members immediate access to pricing when needed, help reduce expenses by eliminating multiple requests for proposals, and obtain discounted pricing through volume purchasing.
