



# Application and Election Process for TREASURER POSITION

2022 LOC Board of Directors

## Position Open

The LOC's Bylaws provide for four Officers, which include the: President, Vice-President, Treasurer and Immediate Past-President. Each year a Treasurer is elected at the Annual Business Meeting. Once elected as Treasurer, the office holder serves a four-year term, with each year advancing the person to a higher level of office. The Treasurer automatically ascends to the Vice-Presidency in their second year on the Board. The Vice-President automatically ascends to the President in their third year on the Board. And finally, after completing the year as President, the person becomes the Immediate Past-President (a position that still retains voting privileges).

New board members will be given an orientation in December and will participate in the Strategic Planning Session with the current Board scheduled on December 9, 2021. New board members will also participate, but not be permitted to vote, in the December 10, 2021 Board Meeting. The new term of office begins with the first meeting of 2022, usually held in late February.

## Nomination Process for Appointed Officials

All candidates for the Board position designated for an Elected City Official Director will be expected to do the following:

***Complete an Application Form.*** Return a completed Application Form (next page) to Angela Speier at [aspeier@orcities.org](mailto:aspeier@orcities.org) by **October 6, 2021**. This will provide the Nominating Committee with general background on all candidates for office.

***Appear Before the Nominating Committee.*** The LOC Nominating Committee will hold a virtual public meeting on Thursday, October 21, 2021. Each applicant will be given a set amount of time to address the committee.
