## Other Discussion/Notes

Mike Savara from Oregon Housing and Community Services (OHCS) shared that OHCS received a total of \$180 million in state general fund investments from the 2022 Legislature. The state is standing up an Interagency Council on Homelessness to better align state resources. OHCS is focused on how to maximize and best blend various funding streams and efforts. They are working on mapping resources and funding. OHCS wants to help create a template to plug in local numbers. Built for Zero is another effort getting started in the state, coordinating with Continuums of Care.

OHCS has funding to support technical assistance for the HB 4123 pilots and wants to know what would be most helpful to the group? Participants discussed briefly but agreed it was a little early to decide on a topic and plan to discuss in more detail at the next meeting. Some initial suggestions included:

- Identifying and addressing gaps in expertise across the pilots
- Help with data collection/coordinated entry
- Communications/Community engagement tools
  - Idea of "lessons learned" from other communities to be brought to us at the local level for our residents to learn from. There has been a tremendous amount of media on failed efforts to address homelessness in other parts of the state and west coast recently. These stories have a very detrimental effect on our ability to craft strategies that could be successful because they foster a belief in the public that nothing works. So a "lessons learned" road show that both showcases efforts that are successful and explains why and also offers some "after action review" insights on efforts that have not been successful would be very helpful. If a feeling that nothing works overwhelms our communities then they will not be willing to try anything.
