

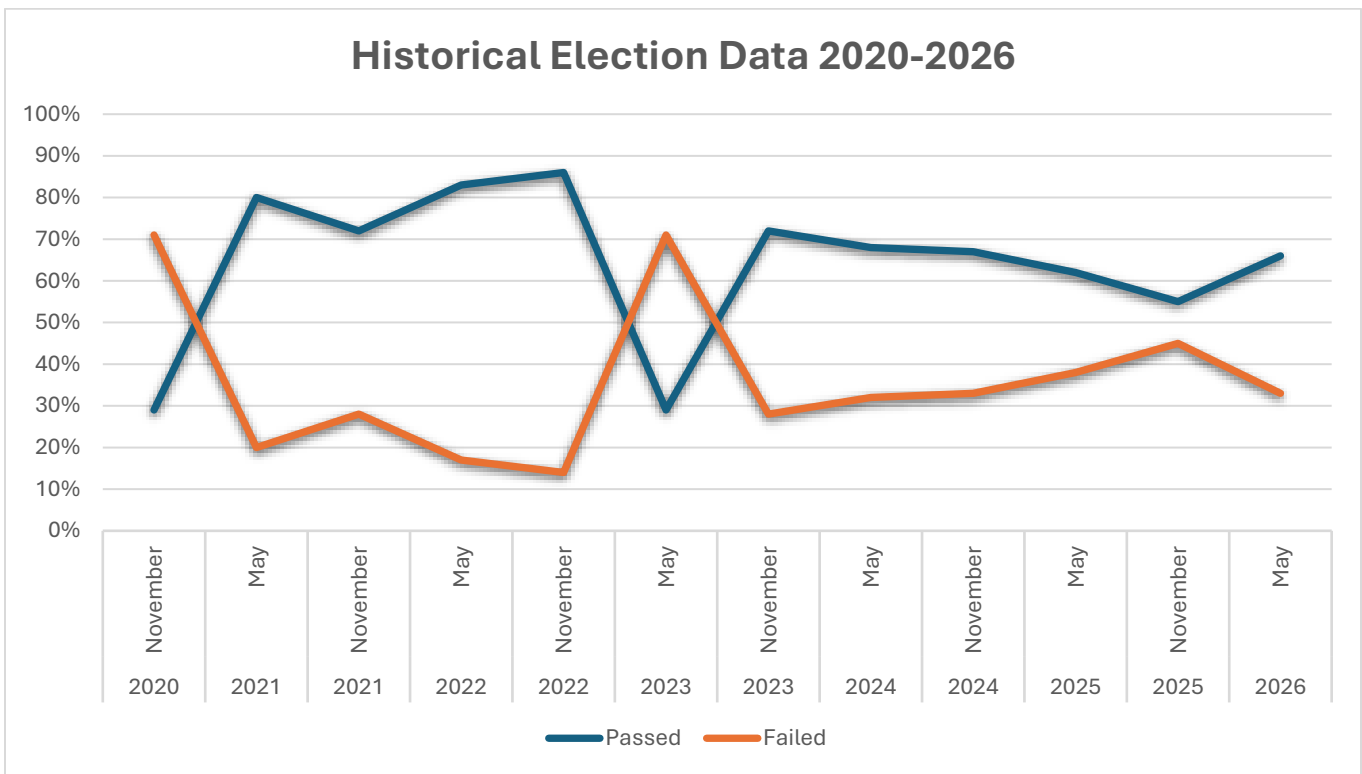


May 19, 2026 Election Report

Below is a summary of the Oregon May 2026 Primary Election. The election had a 35.41% voter turnout, with about 1,093,753 ballots counted, according to the [Oregon Secretary of State website](#).

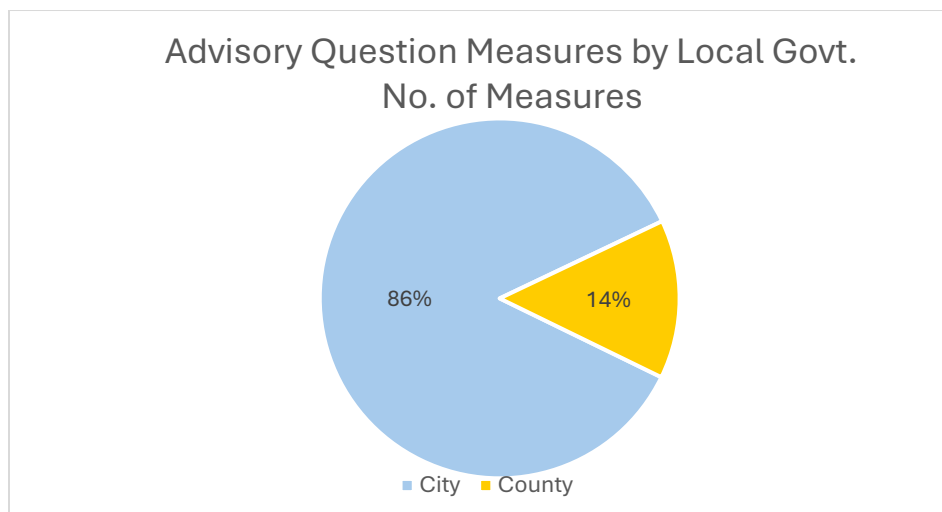

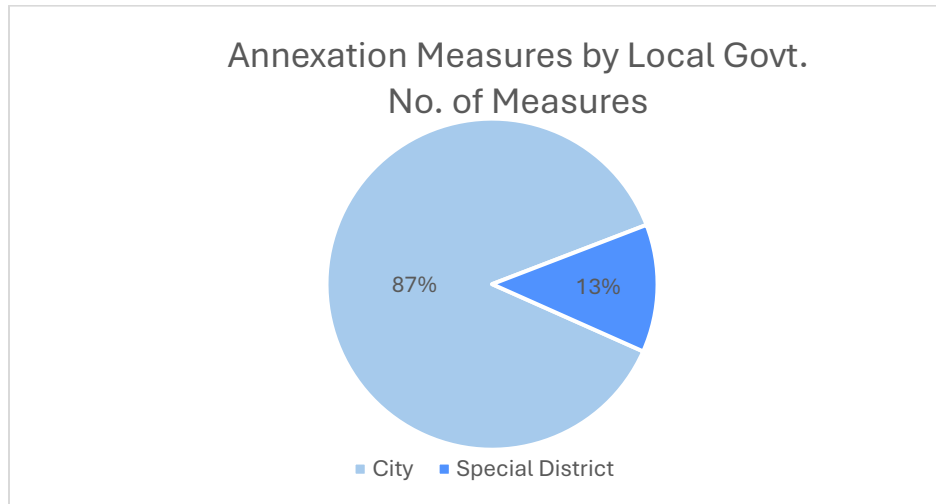

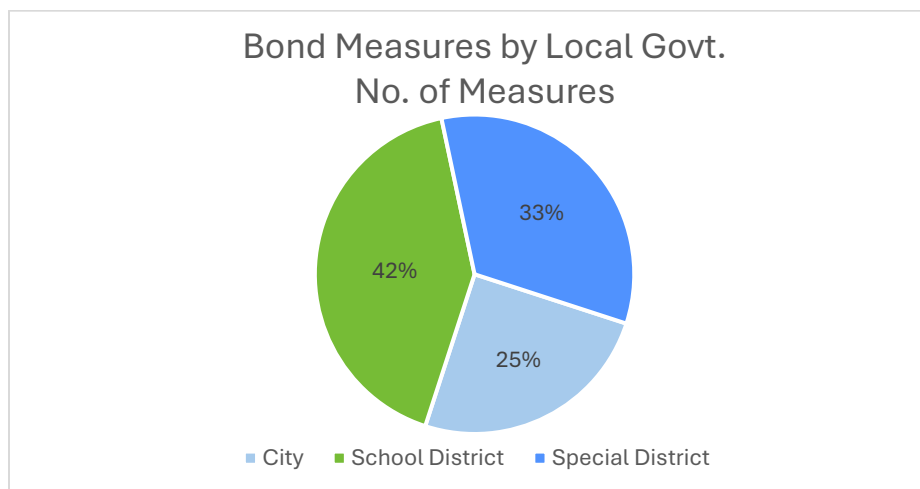

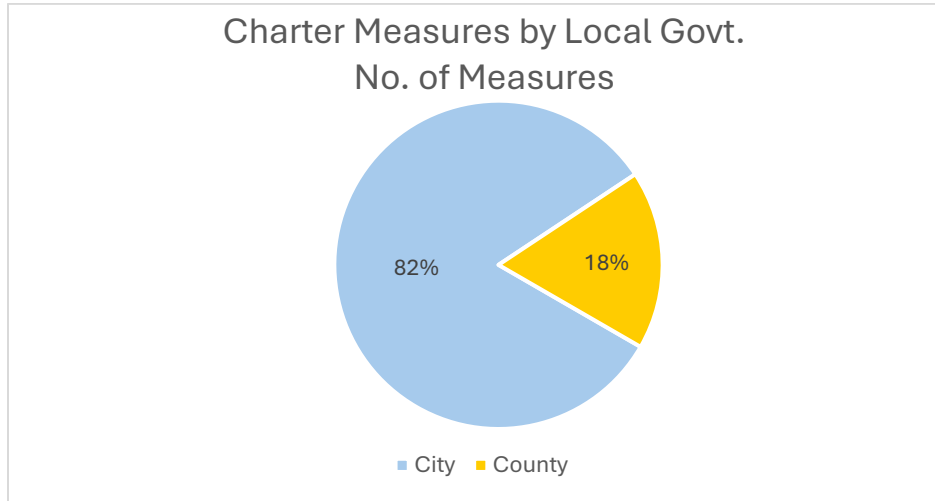
